GENERAL INFORMATION

Q-Bio Magnesium 3.0% is designed for foliar and soil application to crops for the prevention and correction of magnesium deficiencies that may limit growth and yield. **Q-Bio Magnesium 3.0%** is water soluble and nontoxic to foliage when it is applied as directed on this label.

DIRECTIONS FOR USE MIX WELL BEFORE USING

FOLIAR APPLICATION RECOMMENDATIONS:

TREES, VINES, VEGETABLE, FRUIT, BERRIES AND FIELD CROPS: Apply **Q-Bio Magnesium 3.0%** at 1-4 pints per acre (1.17-4.68 L per Hectare) in sufficient spray volume for thorough coverage (25 gallon (95 L) minimum) as needed.

SOIL APPLICATION RECOMMENDATIONS:

TREES, VINES, VEGETABLE, FRUIT, BERRIES AND FIELD CROPS: **Q-Bio Magnesium 3.0%** is recommended for use on all soil types at a rate of 1 quart to 2 gallons per acre (2.34-18.71 L per Hectare) depending on soil conditions and application methods. It should be diluted before use to ensure uniform coverage. Dilution may be made in water, compatible fertilizer solutions, or with compatible pesticides (use jar test to determine compatibility). Soil applications may be made by drip irrigation.

AERIAL APPLICATION RECOMMENDATIONS:

TREES, VINES, VEGETABLE, FRUIT, BERRIES AND FIELD CROPS: Apply **Q-Bio Magnesium 3.0%** at 1-2 pints per acre (1.17-2.34 L per Hectare) in sufficient spray volume for thorough coverage (10 gallon (38 L) minimum) as needed.

WARNING
